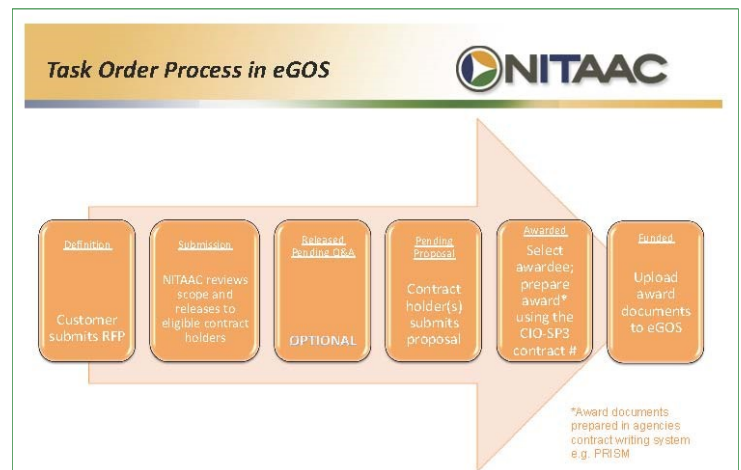
CIO-SP3 Task Areas
